The Upper Midwest Law Center is a center-right, non-profit public interest law firm founded in 2019 by Attorney Douglas P. Seaton.

Before the founding of UMLC, citizens and businesses wronged by governmental agency overreach, public union corruption and misconduct by special interests relied upon private parties or pass-the-hat techniques to support their cases. Although these methods often worked, this was an inefficient system which often resulted in windfalls or shortfalls for the private law firms involved.

UMLC’s lawyers work without charge to clients, and legal recoveries are repurposed to fund additional litigation. UMLC works to change laws, rules, and practices and fight unlawful actions that violate citizen rights and hamper business operations in Minnesota and beyond.

Our lawsuits are vetted by our Lawyers Advisory Board, with some of the best legal minds in Minnesota. UMLC works cooperatively with Center of the American Experiment, “Minnesota’s Think Tank.”

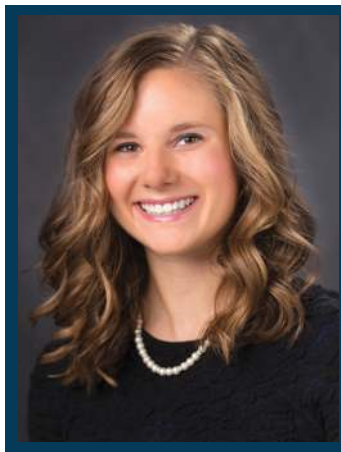


Doug Seaton, President

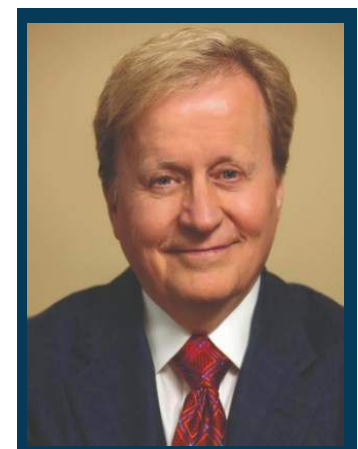
